In the event of an emergency, I/we give permission to Stellar Athletics Sports Center and/or appropriate medical facilities to take all measures deemed necessary for the care and protection of my child while under the direct supervision of Stellar Athletics Sports Center. I/We further understand that in the case of an emergency, my child will be transported to the preferred hospital emergency room (listed above) by a local emergency unit in the event immediate and emergency medical services are necessary. I/we further understand that in a medical emergency situation, Stellar Athletics Sports Center has permission to act on the parent's behalf for the well-being of the child and contact medical emergency services in the event the parent, physician or the emergency contact listed above cannot be located. **Financial, Moral & Commitment Agreement:** This is a binding and contractual agreement between the PARENT, the ATHLETE and Stellar Athletics Sports Center which states the following:

**Financial:** I agree to satisfy all financial obligations incurred as a result of my child's participation in the STELLAR ATHLETICS cheer and dance program on time and on a consistent basis. I understand that I am in partnership with the organization and that my ON TIME payments benefit both the organization and my child. I fully agree to fulfill my financial obligation to the organization by paying account fees each month in full and ON TIME. I understand that delinquent accounts and unexcused absences are grounds for dismissal from the program. I understand that no payments will be reimbursed after payment has been received by Stellar Athletics Sports Center. In the event I and my child leave the program during the course of the season for any reason, I understand that no fees paid will be reimbursed to me upon early departure, and that a \$125 early termination fee will be applied to my account and due at the time of my departure from the program.

**Moral:** I understand that I am in partnership with the organization and therefore, agree to display full moral and physical support of the organization by exercising good sportsmanship at any Stellar Athletics Sports Center sponsored event, conducting myself in a civil manner when wearing STELLAR ATHLETICS apparel, and refraining from gossip and/or slander of any coach, athlete, parent or other area gym in person and/or on any social media site or app. I understand that I am not permitted to post any performances of competitions on YouTube, Facebook or any other social media site during the half season. I understand that if I or my athlete is found in violation of this agreement, it could result in dismissal from the program.

**Commitment:** I further understand that both mine and my child's participation in the STELLAR ATHLETICS program is a commitment for the ENTIRE allstar season and that WE will remain in the program for the entirety of the current season. I further agree to ensure my athlete participates in each scheduled practice and/or competition and that I will not keep my child from practice as a form of punishment, as I realize that punishes the team as well. I understand that in the event the athlete has one (1) unexcused absence from practice or one (1) unexcused absence from a competition or STELLAR ATHLETICS event where attendance is mandatory, the athlete will receive automatic dismissal from the squad.
